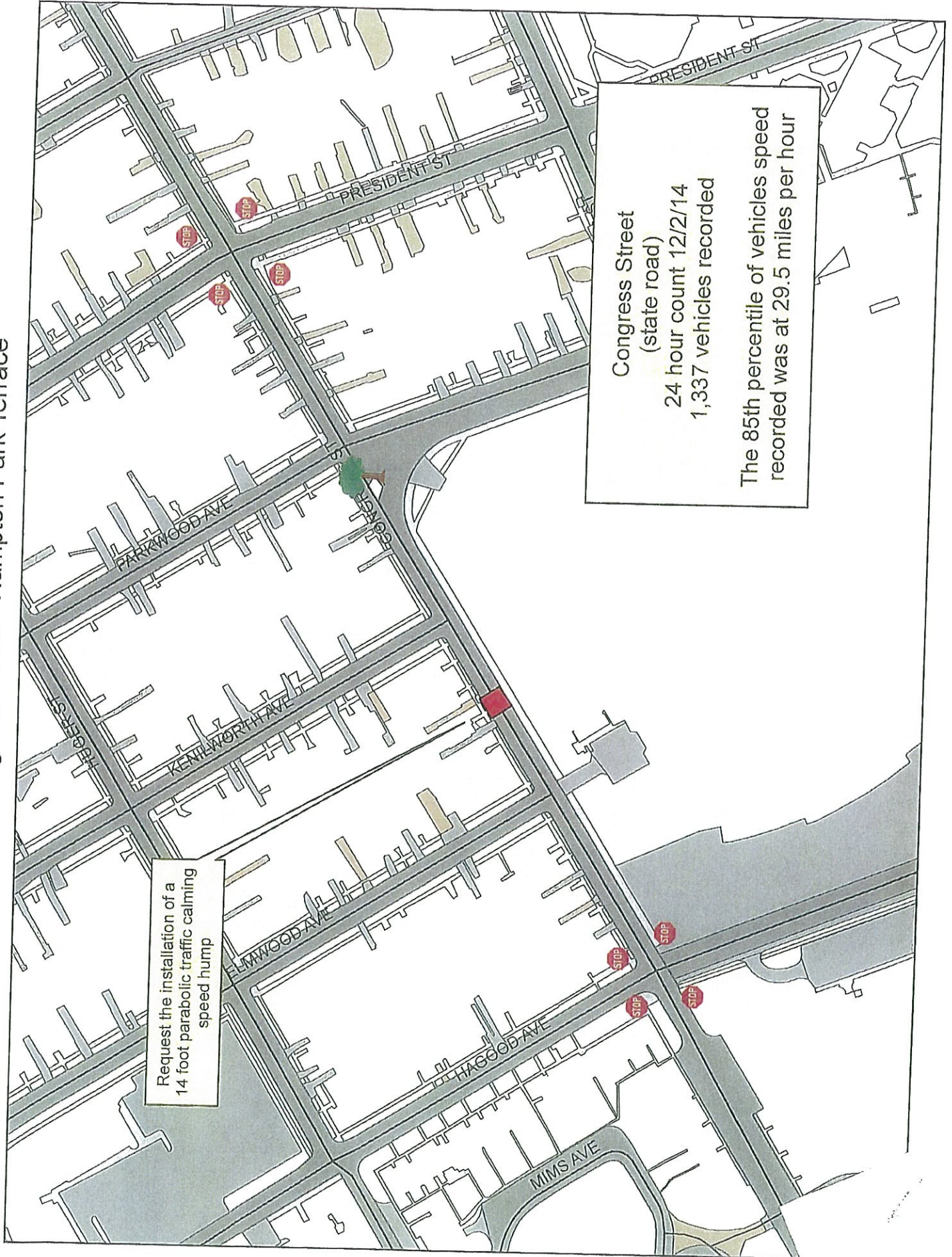

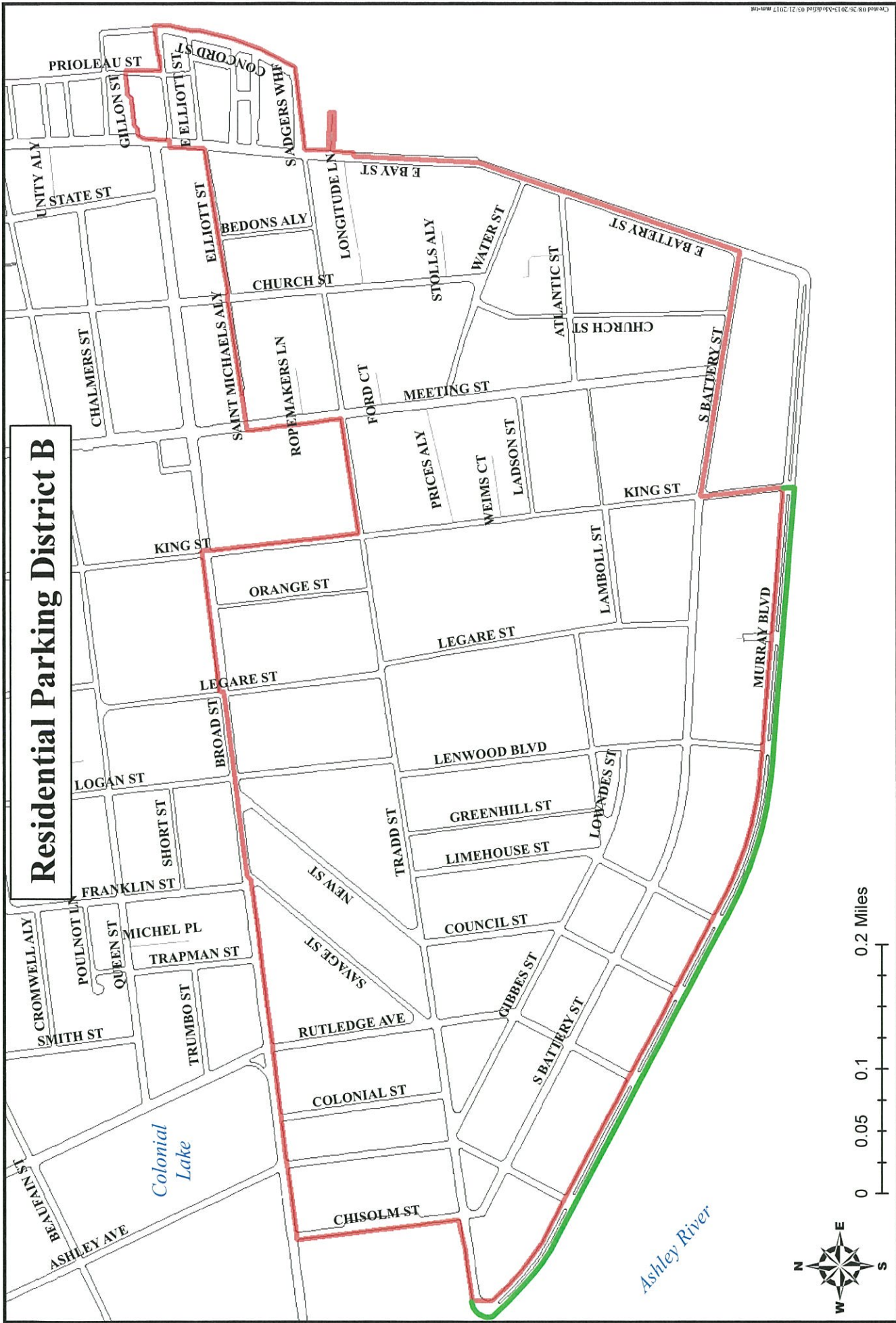
Congress Street - Hampton Park Terrace
