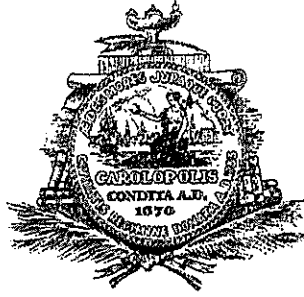

AN ORDINANCE

AMENDING ARTICLE II-RECREATION DEPARTMENT; SECTION 22-24-MUNICIPAL GOLF COURSE-MANAGEMENT.

BE IT ORDAINED BY THE MAYOR AND COUNCILMEMBERS OF CHARLESTON, IN CITY COUNCIL ASSEMBLED:

Section 1. That Article II; Section 22-24-Municipal Golf Course-Management shall be amended to read as follows:

Sec. 22-24. – Municipal golf course-Management.

The facilities of the municipal golf course shall be managed, operated and supervised by the golf course manager who shall report to the Special Facilities Manager of ~~director of recreation~~ the Department of Budget, Finance and Revenue Collections.

Section 2. That this Ordinance shall become effective upon ratification.
