STAFF COMMENTS:

1. Staff recommends returning the cornice back into the roof a few feet farther so that one cannot see the ends of the return. (Please provide a roof plan at the next review.
2. Staff is supportive of the grill and vine plantings at the ground level. At next review please provide more detail on this material.
3. Looking at the SE elevation, there are 3 wood fence enclosures shown that do not match what's shown on most of the plans. Only the trash enclosure is shown on the Civil plans. If these other two mechanical enclosures are to remain, we recommend adding planting beds a few feet wide for shrubs, in front of each of these enclosures.
4. There are two landscape plans that differ. One plan is the 2nd to last sheet that shows more of an accurate occurrence of the wood enclosures at the back of the building. But in this one the trash enclosure is not shown. The 2nd landscape plan provided is sheet L-100, that does not show these other 2 wood enclosures, as well as all the Civil plans that do not. Please have all plans matching and please provide only one landscape plan.
5. Study the location of the trash enclosure shown on the Civil plans. Is there room off to the side rather than in between the two building entrances?
6. A materials key was provided for the elevations but in some cases was still difficult to distinguish which material was what on the buildings (i.e., windows). In addition to the key plan, please also provide a label pointing to one of the material locations as an example/confirmation.
7. There is a conflict with the roof slope vs the top of windows as seen in the SE elevation, where the roof slopes down and is very close to the top of the windows. At preliminary review, we will need to see more detail.

STAFF COMMENTS:

1. The landscape plan shows some of the Burford Hollies being planted under existing trees along Henry Tecklenburg Dr. which staff does not recommend. The Burford Holly can get 25 ft tall if not maintained. We recommend an evergreen shrub that does not get so tall if being planted under a shade tree.
2. Staff recommends showing some smaller caliper existing trees saved in between the fairways and at the property perimeter. Where appropriate this could be shown as a circled area and labeled tree save area....or show the individual trees to be saved from the survey.
