| Cancellation | Cancel 14 days or more prior to date of event: Full Refund of Rental Fees and Deposit. Cancel 7-13 days prior to date of event: 50% of Rental Fees and Deposit Refunded. Cancel 0-6 days prior to date of event: No Refund of Rental Fees or Deposit. |
| Rescheduling Fee | \$25/schedule change (date, time, and/or location). Excludes weather-related changes. |
| Permit Application Fee | Non-refundable |
